This Month's Meeting is Thursday, September 17 at Niko Niko's



Bernardo Plantation Report for August 17-21, 2009

First off, thanks and appreciation go out to all who contributed their time and efforts to our first full week of work done at Bernardo and Pleasant Hill. We had a very busy and productive week, not only on the ground, but on upcoming publicity and fund raising potential. The Associated Press had reporters in the field on the 19th and KTBU TV Channel 55 (incidentally owned by our wonderful land owner, Greg Brown) began their first filming on the 20th. The AP article came out in The Houston Chronicle on Sunday August 23, 2009, in Section B, page B2. All this publicity should give the project wide exposure.

Since our last update, we have signed on our new Co-Principal Investigators (PIs), those being Robert Marcom and Carol McDavid of Community Archaeology Research Institute, Inc.

The work for the week concentrated on four major areas, (1) the Bernardo main house and outbuildings; (2) the family cemetery; (3) the slave quarters at dry Lake Bernardo; and (4) the task of locating the Pleasant Hill main house, stables, and slave quarters.

Results of the magnetometer survey indicate the location of the main house, possible "bachelor quarters", possible domestic slave cabins, and the remnants of a road. At the Lake Bernardo slave quarters, the magnetometer located what appears to be partial slave cabins, however there is an indication that they continue under land which is now part of FM1887. The GPR was used at the cemetery, but dry soil conditions, gopher holes, and ant mounds made on-site interpretations difficult. One team spent the entire week trying to locate the Pleasant Hill complex.

Hand-held metal detectors were used to establish the presence of metal object concentrations which would indicate areas of high activity and occupation.

Some artifacts were collected, photographed, and bagged by Robert Marcom or Carol McDavid. Others were left in situ, recorded and covered back up. This approach led us first to determine the probable location of the Pleasant Hill stables, and, in all probability, the location of the main house. Due to the lack of time, no evidence of the associated slave quarters was found. Artifacts were recovered in each of the following artifact type groupings: Kitchen - stove parts, plate lifter, Dutch oven; Architecture – square nails, cast iron fence part; Furniture - Oil lamp burner, misc, unidentified brass fixture parts, and a circular medallion- shaped disc with a horse impressed on it; Activities - hoe blade, small hand forged hatchet, brass tack rivet, hitching ring, brass padlock, and misc. possible wagon parts.

Our next work dates are in pending the analysis and review of all that has been done to date. Hopefully it will be within the next several weeks and will include some weekend work for those who cannot spare the time otherwise. If anyone reading this has not already received volunteer requests or update reports from me, it probably means you're not on the list or your email address is in error.
