



## Dub Crook Returns with an Update on Brushy Creek

Wilson W. Crook III (“Dub” Crook), HAS member and avocational archeologist, will be the speaker at the December meeting, with a program on “Return to Brushy Creek.”

Our December meeting will be at 7:00 pm Thursday, December 15, in Anderson Hall (Room 103) on the Academic Mall at the University of St. Thomas.

Dub Crook is the Manager of Global Gas Regulatory & Legislative Issues for ExxonMobil Gas & Power Marketing Company. However, as the son

of a professional archeologist, he was introduced to this field of study at a very early age, and he has made significant contributions to the body of archeological knowledge through his own work.

Dub has published numerous papers in archeology, mainly focusing on the Upper Trinity River watershed but also sites in West Texas, New Mexico, Nevada, California, and Virginia. He has also worked in the rift valley of East Africa, in South America (Bolivia, Argentina, and Peru) and in Kazakhstan. He has been a member of the Texas Archeological Society for 34 years, a member of the Center for the Study of the First Americans,

The archeological association of Virginia and HAS.

“My father was Wilson W. Crook Jr., (“Bill” Crook) who was Past President and fellow of the Texas Archeological Society. I naturally grew up being dragged all around the world to archeological sites as he was a confident of Helmut de Terra, Louis Leakey, Thor Heyerdahl and others,” he says.

D. Hughston, discovered the Brushy Creek Clovis site in Hunt County, TX (41HU74) in 2004. The site to date has produced one Clovis point, a large Clovis perform, a number of apparent Clovis blades and other tools.

Dub will review the latest thinking in terms of what Clovis sites are producing across Texas, discuss the Brushy Creek finds, and review the work that remains to be done at this site.

## LEARN TO READ STONE ARTIFACTS

The Texas Archeological Society will sponsor the Texas Archeology Academy titled “**Lithics: Reading Stone Artifacts,**” **February 4-5, 2012**, in Uvalde, Texas. This workshop will provide hands-on experience in the recognition of stone artifacts, their manufacture, and how they contribute to our understanding of ancient people. Classes will be held **at Quality Inn in Uvalde, 920 E. Main, 9:00 am to 4:00 pm each day.**

Instruction will include how stone tools were made and what we can learn from them. Stone tools preserve longer than any other human artifacts. Much can be learned about people from the way they solved problems basic to survival. The stone tools often reveal what tasks were performed showing how ancient people lived. Dr. Harry Shafer, professor emeritus of archaeology, Texas A&M University, will teach the academy, with assistance from Paul Smith and David Calame. Two full days will be conducted in the classroom with lunch provided.

The **registration fee is for two days instruction: TAS member \$95; non members, including individual membership \$155; non member including family membership \$165; student non-member including membership \$135.** That includes lunches (2) and a manual on CD. A certificate of participation will be awarded to attendees. CPE credit will be available for teachers as approved by the Texas SBEC. ### New on TBH: Analysis of Ceremonial Cave Darts

New research on a group of remarkably well preserved darts from **Ceremonial Cave**, an El Paso area shrine site, is reported in this newly updated and expanded TBH exhibit on [www.texasbeyondhistory.net/ceremonial/hafted.html](http://www.texasbeyondhistory.net/ceremonial/hafted.html).

TARL Director Darrell Creel initiated a study of seven of the darts, which still hold chipped-stone points hafted within their foreshafts. AMS dating and high resolution X-ray computed tomography (CT) scanning were used to examine these rare, perishable objects, likely left at the cave as ritual offerings by early Puebloan pilgrims. CT scans of the dart tips revealed the basal area of the chipped-stone points beneath their sinew wrappings, enabling determination of their shape and style. Most of the points appear to be type Carlsbad; another may be the earlier dart point form known as Hueco.

In the new, interactive, **Hafted Dart Point Analysis** section, viewers can study the darts through a series of rotating “movies” with 3-dimensional details generated for each object. These include complete views of the dart point basal sections beneath the hafting materials. Radiocarbon data and other information are reported in the various sections of this mini-exhibit. The new section, **What We've Learned**, summarizes latest findings and ongoing research on other Ceremonial Cave artifacts.

We now know that the ritual placing of darts and spears as offerings began at Ceremonial Cave about 2000 years ago, if not centuries earlier, indicating the site was one of the earliest shrine caves in the greater Southwest. Additional research is underway on other items from the cave, including *pajos*, or prayer sticks, and throwing sticks.
